## **SOCIAL SERVICES**

Social Services is the name given to the people, procedures, actions and resources assigned and designed to improve the advancement and full development of all people and groups, enhancing social well-being and quality of life in an environment where socially disadvantaged people, families and groups all live together.

# I. Who is entitled to use Social Services (SS)?

Generally speaking, these services are available to Spanish nationals who are registered in one of the Valencia region's municipal areas, citizens of the European Union Citizens who are resident in the Valencia Region, extra-community citizens, exiled persons, refugees and stateless persons resident in the Valencia Region are entitled to the rights and services of the Public Social Services System. Entitlement is set out in a number of regulations, treaties and international agreements.

## II. Levels of care provided by Social Services

The Government Public Services System has a two-tier social services structure:

- a. Primary level care consists of General Social and Community Services and provides primary social care to the entire population. At this level, a social worker in the town where the person is registered is assigned to make an initial assessment of the situation. At this stage, multidisciplinary teams deliver an integrated, multi-faceted service to the general public, through preventive measures, assistance and rehabilitation. These services are available to all and are free of charge. They are run by social services centres attached to Local Authorities.
- b. Secondary level of attention consisting of Specialised Social Services, which focus on certain sectors of the population which, because of their conditions, age, sex, disability, nationality or some other social, cultural or economic characteristic, require more specific attention from a technical and professional point of view. These services are sometimes managed by regional government (the Generalitat), by local entities in their territorial areas or by institutions or associations that may be privately funded or financed by those affected by the specific need in question.

Pursuant to Law 5/1997 of 25 June of the Valencia Regional Government (Generalitat Valenciana), Social Services in the Valencia Region delivers care for the following groups: families; children and youth, the elderly, people with disabilities, the drug dependent, the terminally ill, women, ethnic minorities and other persons at risk of exclusion.

## III. General Social Services. What is a Social Services Centre?

The Social Services Centre is the first level of response from the Social Services System to all claims and social needs. It is the gateway to the system, the first point of contact. These services are available to the entire registered population and because they are provided locally, users are guaranteed immediate access. Their functions include the following:

- These centres provide information, carry out assessments, make diagnoses and give guidance to the population about their rights, available social resources and possible social interventions.
- They provide domiciliary care and support to the 'unit of coexistence' (family).
- Preventive measures can be taken in situations where there is a risk or social need.
- They manage emergency social benefits (financial air).
- They encourage the setting up of associations for social cooperation.
- They cooperate with and encourage the community, social organisations and citizens to become actively involved in the social matters that affect them most directly.

## IV. How can citizens access the Social Centre?

The procedure for using the social centre is established by each local authority, but usually you can telephone or call in to make an appointment.

Densely populated towns and cities such as Alicante, for example, have several Social Centres. Citizens are assigned to one or another according to where they are registered. (\*)

Users generally are usually referred to specialised or secondary level social services by their primary care level when the need is identified. However, being seen at a primary level social centre is not a prerequisite to receiving specialist attention, and users may be referred immediately if the circumstances make this advisable.

## V. Alicante Provincial Council

Alicante Provincial Council does important work in the Social Services area, primarily to support and cooperate with local authorities and groups of these, although it also delivers certain services and facilities directly to citizens.

Alicante Provincial Council has its own Social Services Department, which shows how important this area is to the Institution. This has an Equality, Youth and Foreigners Department, which designs and runs intervention programmes in different areas with groups in need of help and intervention.
